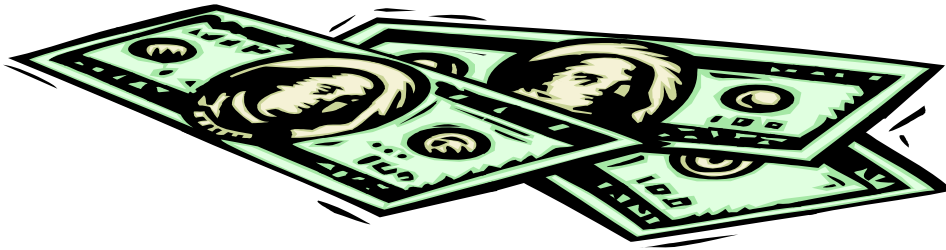


#### **MEMBERSHIP DRIVE**
